

Sample Contract 1 – This is a sample of a more romantic D/s relationship style contract which is loose in it's definitions and limits of submission

I, _____, with a free mind and an open heart; do request of _____ that he accept the submission of my will unto his and to take me into his care and guidance, that we may grow together in love, trust, and mutual respect. The satisfaction of his wants, desires, and whims are consistent with my desire as a submissive to be found pleasing to him. To that end, I offer him use of my time, talents, and abilities.

Further, I ask, in sincere humility, that, as My Master, he accept the keeping of my body for the fulfillment and enhancement of our sexual, spiritual, emotional, and intellectual needs.

To achieve this, he may have unfettered use of my body any time, anyplace, in front of anyone, to keep or to give away, as he will determine. I ask that he guide me in any sexual, sensual, or scene related behavior, both together with, and separate from him, in such a way as to further my growth as a person. I request of _____, as My Master, that he use the power vested in his role; to mold and shape me; assisting me to grow in strength, character, confidence, and being, and that he continue to help me to develop my artistic and intellectual abilities.

In return, I agree:

1. To obey his commands to the best of my ability.
2. To strive to overcome feelings of guilt or shame, and all inhibitions that interfere with my capability to serve him, and limit my growth as his submissive.
3. To maintain honest and open communication.
4. To reveal my thoughts, feelings, and desires without hesitation or embarrassment.
5. To inform him of wants and perceived needs, recognizing that he is the sole judge of whether or how these should be satisfied.
6. To strive toward maintenance of a positive self-image and development of realistic expectations and goals.
7. To work with him to become a happy and self-fulfilled individual.
8. To work against negative aspects of my ego and my insecurities that would interfere with advancement of these aims.

I agree to serve my Master loyally, and faithfully, until such time as he sees fit to release me.

Sample Contract 2 – This is a more legal looking contract that specifically spells out certain aspects and limits of submission

This Agreement is entered into this 5th day of April, 1992, by and between _____ (hereinafter referred to as “Master”) and _____ (hereinafter referred to as “Servant”).

WHEREAS, Master has experience in the management of persons’ behavior for the purposes of helping those individuals to fully realize their full potential; and WHEREAS, Servant has demonstrated her inability to realize her full potential without such guidance; and

WHEREAS, Servant has requested that Master assume the responsibility of managing her behavior until such time as Master may determine that no further management is necessary; and

WHEREAS, subject to the covenants and provisions contained herein, Master has agreed to Servant’s request.

NOW, THEREFORE, the parties hereby agree as follows:

1. Term. The Term of this Agreement shall commence on the date first above written and shall continue until such time as Master shall release Servant from the provisions hereof or until otherwise terminated in accordance with the provisions hereof. Servant shall have the option to request release from the provisions of this Agreement at all times. Notwithstanding the foregoing, Servant agrees that no release herefrom shall be valid without Master’s written consent to said release.
2. Covenants of Master. Throughout the Term of this Agreement, Master shall:
 - A. Provide behavior management services to Servant. Such services shall include instructions to Servant with respect to any matter, without limitation of any kind whatsoever, which Master feels, in his sole opinion, is appropriate to Servant’s developing her full potential.
 - B. Provide corrective services to Servant. Such services shall include discipline and punishments, without limitation of any kind whatsoever (except as noted below) with respect to type or severity, which Master feels, in his sole opinion, will provide incentives to Servant to behave in accordance with Master’s wishes. Notwithstanding the foregoing, no discipline or punishment shall involve permanent marking or disfiguring of Servant.
 - C. Communicate with Servant on a regular basis to carry out the provisions of Paragraphs A and B, above. Such communication shall be at the convenience of Master and in such manner as he may choose from time to time.
 - D. Consider all requests from Servant with respect to the activities contemplated hereunder, provided however, that the parties hereto have agreed that the decision of Master with respect to such requests shall be in the sole discretion of Master.
 - E. Provide a concise list of expected duties, activities, etc. to Servant. Such list may be amended from time to time at the sole discretion of Master. The duties, activities, etc contained in such list shall constitute the standard behavior expected of Servant and in no way shall be construed so as to limit Master’s ability to instruct Servant at any time as he deems fit.

F. Be accountable to Servant for any failures of omission or commission. Such failures shall be documented by Servant on a timely basis and reported to Master not less than monthly during the Term hereof. Master's expiation for such failures, which shall be uncontested by Master, shall take the form of discipline or punishment as determined by Servant and shall be delivered at the first possible opportunity.

3. Covenants of Servant. At all times during the Term hereof, Servant shall:

- A. Conduct herself in accordance with Master's instructions and with the list of expected duties and activities.
- B. Accept, and if necessary, self-inflict, all required disciplines and punishments.
- C. Be available at all times to receive communications from Master and respond thereto, if required, in a timely manner.
- D. Maintain a diary of all transgressions both with respect to the list of expected duties and activities and with respect to any other instructions given by Master. Servant shall begin each communication with Master by reciting the current entries from such diary.
- E. Maintain a record of Master's failures in accordance with Paragraph 2F, above.
- F. Seek Master's permission for all behavior which falls outside the scope of normal day-to-day activities, normal marital relations, or the scope of the relationship contemplated herein.
- G. Be in all ways respectful to Master.

4. Confidentiality. The parties hereto agree that at all times they shall maintain the confidentiality of each other's identity, including name, place of residence, manner of employment and name of employer from all other persons. Notwithstanding the foregoing, Servant shall and Master may acknowledge each other's existence and role under the names used herein.

5. Free Will. The parties hereto hereby acknowledge that they have entered into this Agreement of their own free will with the intent to be bound by the provisions hereof. Further, it is understood by the parties hereto that nothing herein shall compel Servant to be mindlessly obedient to Master. Servant acknowledges, however, Master's right to discipline or punish servant for any willful failure to obey.

Sample Contract 3 – This is a simple type of contract, but it specifically spells out the limits and scope of submission and expectations

i, _____ understand and agree to all of the following:

1. i am now an owned slave. The terms of this contract shall continue until _____ shall deem it null and void, or until i speak my “safe word,” at which time the relationship shall end permanently.
2. i am to be considered property of my Master/Mistress.
3. i hereby give up ALL personal freedoms to Master/Mistress. i now live only to give pleasure to Him/Her in any way He/She requires.
4. Master shall decide what i may wear, when any clothing is allowed at all. All undergarments shall immediately be given to charity or disposed of. These shall never be worn. If no clothing is specified for any given day by Master/Mistress, i will assume that no clothing at all is allowed. If alone in the house and the doorbell rings, i will answer the door by, to the extent possible if nude, showing only my head and shoulders to the person at the door.
5. i shall assume all domestic duties of the household, including cleaning and cooking. i shall take care of these duties, as much as possible, when Master/Mistress is not home, so i may be available for other duties when He/She is home.
6. i shall submit to the alteration of my appearance by Master/Mistress in any way. These alterations may include changes in hairstyle/color, shaving of various areas of my body, makeup amount and style, piercing, brands, tattoos, etc. i understand that any of these changes may be of a permanent nature.
7. All of my personal property is hereby freely given to Master/Mistress, and He/She may keep it or dispose of it as He/She sees fit. i come into the relationship owning NOTHING, including cash, except for a savings account of \$ _____ which will not be available to me. i will open a safe deposit box, for which only i will have the key. The saving account passbook shall be kept there. In addition, Master/Mistress will give me the amount of \$ _____ each month to deposit in this account. This check will be given to me on the first day of each month to deposit into my account. Access to this account is only to be given on the 1st. This money is freely given to me in case the relationship ends. Punishments do not affect this account. Unless the relationship ends, i have no access to this money at any time. Other than this money, if/when the relationship ends, i will take NO cash or possessions from Master/Mistress. All money and possessions, with the exception of the above named account is His, and i will never make claim to any part of it.
8. i will not be employed outside the home unless Master/Mistress specifically orders it.
9. i may not use the telephone without Master’s permission, the exception being in case of medical or other emergency. At all times, i will answer the telephone “Hello Master/Mistress” when Master/Mistress is not home.
10. i may spend a small amount of time each day on the Internet , to be paid for by Master/Mistress as a household expense.
11. Master/Mistress owns all aspects of me, including my sexual self. He/She may offer me for sex acts to any other man or woman at any time. i understand that i will be used sexually a great deal by Master/Mistress in any way He/She desires, and at any time or

place He/She desires. my vagina, ass, and mouth are to be ready constantly for His/Her or others' use.

12. i understand that the above provisions include service IN PUBLIC at any and all times. i shall always refer to _____ as "Master/Mistress," even in public places, unless Master/Mistress uses my code name_____. At that time, i will refer to Him/Her as _____.
13. Everyone i know, including any friends i am allowed to keep, will know that i am the slave property of Master/Mistress.
14. i understand that there are to be NO LIMITS to any of the above, including the use of punishments such as pain. We agree that Master/Mistress will not commit, and will not require me to commit, any act which is a felony under state or federal law.

We, the undersigned, agree totally with the above.

Sample Contract 4 – This contract is more of a relationship contract that defines the scope of both master/mistress and slave within the confines of a relationship

Relationship Agreement

This agreement between _____, hereafter referred to as Master, and _____, hereafter referred to as slave, effective from the date of _____, was freely entered into by both parties after a period of discussion and negotiation and is morally binding upon both parties from said date. The master agrees to inflict no severe form of pain on the slave. This includes no crops, whips, or other implements. The master is allowed to spank the slave on the buttocks with his open hand, but is not allowed to inflict any severe beating. Severe is defined as any damage making it difficult for the slave to walk, sit, or to function in her daily life, or causing a large amount of bruising. Nipple clamps may be used on the slave as long as they are not tight enough to cause pain. Any other explorations of pain will be done after mutual discussion, and the slave has the right to refuse to participate at any time. The master understands that the slave has an aversion to pain and indicates that this restriction is acceptable to him. The master agrees not to punish the slave for things that are not under her control and to inflict no unduly harsh punishments on the slave. Punishments that are deemed to be unduly harsh may be discussed, although the master has the deciding vote. The slave is allowed to attempt to talk, coax, or bribe her way out of any punishment, but must cease any attempt at the master's command.

The slave agrees that the master may have other slaves at his discretion. Both parties agree that at no time will there be any activity involving minor children, animals, "watersports", feces, any other product of elimination, non consensual sex, knives or other dangerous objects.

Any electrical objects involving direct current will be agreed to in advance by both parties. The master agrees that the slave is a person and is not to be subjected to being treated as an animal.

Both parties agree that there will be no activity that will harm the career potential of either party, no public scenes that might result in arrest or other legal consequences, or might bring their D/s activities to the notice of family, friends, or co-workers who would not approve this lifestyle decision. Both parties agree to be discreet in their discussion and activities. The slave agrees to wear a collar or other item provided by the master when at home, or at functions where her status is an open one, indicating that she is an owned slave and the property of the master. She is not required to wear this item in public to be an item of normal jewelry, when expecting guests, or when sleeping. She is further not required to wear a collar at times when it may interfere with her breathing or health such as when she has a respiratory illness.

The slave agrees to dress in whatever manner her master wishes except when dressing in such a manner would conflict with the provisions safeguarding their reputations. The slave agrees to have sexual relations only with the permission of the master.

The slave agrees to have sexual relations with anyone that the master chooses. The only exception to this are persons who the slave finds totally repulsive to her. The slave agrees to identify to her master any person that is this repulsive to her at the first opportunity in any situation where she might expect her master to offer to “share” her. The master agrees to abide by the slave’s feelings in this matter.

The slave agrees to obey ANY commands given her by the master except when they conflict with any other provision of this agreement.

The slave agrees to not talk with other masters except when under her master’s direct supervision or with his specific permission.

(Amended 3/31/95-the slave may speak to other masters at her discretion on line only.) The master agrees to safeguard the slave from any harm or any consequences of obeying his orders.

The master agrees to protect the slave from any harm to her reputation, eg. being filmed during a D/s encounter, etc., or to her person, eg. abuse from a dominant she has been “lent to.”

The master agrees to attempt to fulfill the slave’s fantasies and desires as part of an ongoing exploration of his and her sexuality. The master is allowed to push the slave to her limits of toleration in this exploration. The slave agrees to attempt to fulfill the fantasies and desires of the master in the same manner. Both parties are expected to communicate wants, needs, and desires to the other party in open communication. Both parties are expected to suggest possible activities and scenes that can be mutually enacted. If they have an issue where their desires or fantasies are distasteful to their partner, they will discuss these problem areas and attempt to reach a solution. At no time will one party attempt to force the compliance of the other party into performing an action that is morally repugnant to that party.

When the master and slave are living full time in the same household, the slave will be responsible for the day to day running of the household, cleaning, meal planning, entertaining, etc. These responsibilities will be under her autonomy. The slave is allowed to perform these functions in her own way and while the master may make suggestions, he may not directly interfere unless he wishes to take over these functions himself. He may, however, punish the slave for failure to perform these functions properly. The master further agrees to provide the money necessary for the proper running of the household. Should this allocation of duties prove unsatisfactory, this clause can be renegotiated for up to one year after the parties take up residence together, and after that by mutual agreement. Both parties agree that in the matter of friendships, business, and other outside relationships, that they will not interfere or attempt to cause embarrassment in said relationships. Both parties have the right to invite their friends to their home and expect the other party to treat them with politeness. Both parties agree that this clause does not apply to criminals, persons suspected of child molestation or rape, or persons that the other party finds personally offensive. Persons in that category must be entertained elsewhere. The slave is expected to exercise autonomy and good judgment in the matter of exercise, diet, and health care. The slave is allowed to coax, remind, nag, complain and otherwise coerce the master into taking his medication on time, eating properly and other aspects of a healthy lifestyle as deemed necessary by HER unless overruled by a physician.

The master agrees not to punish the slave for her care of him in these matters. The master agrees not to undertake any D/s activity with the slave in any situation in which he is feeling angry with said slave. The master is expected to exercise self control at all times.

Any matters not directly addressed in this agreement must be discussed by both parties and no action changing the status quo taken by either party until an agreement is reached. This agreement is subject to renegotiation and amendment by mutual agreement at all times.

This relationship is expected to last until the death of one of the parties, but it is understood that this is not always the case. There may come a time when the parties may decide to rescind this agreement. It is expected that this will not occur without attempts by both parties to resolve their differences amicably.
